They are to pay Ph.D. registration fee of Rs. 5000/- (Rupees Five thousand) within one month from the date of issue of this letter, failing which the permission for registration will stand automatically cancelled. Further, they will pay Rs. 150/- (Rupees one hundred fifty) only per month from the month of effect of your admission to the month of submission of their theses. If they fail to pay the monthly fee of Rs. 150/- for six months at a stretch their admission for Ph.D. will be cancelled.
