***Terms of References :***

- (1) The Vigilance Wing shall be headed by the Vigilance Officer who shall perform the following tasks :
  - (a) Collecting information about the corrupt practices committed, or likely to be committed by the members of the University;
  - (b) Receiving complaints from all sources; investigating or causing an investigation to be made into verifiable allegations reported to him; processing investigation reports for further consideration of the disciplinary authority concerned; processing the investigation reports expeditiously for obtaining orders of the competent authorities about further course of action to be taken.
  - (c) Inspecting and ensuring that the construction works of the University are strictly in conformity with the approved norms and specifications.
- (2) The Vigilance Officer shall adopt measures for preventive vigilance, surveillance and detection and cause preliminary investigation, as maintained by the Vigilance Ordinance for Dibrugarh University.
