Online Applications are invited from eligible intending candidates for admission to the AICTE approved Two Year (Four Semester) MBA (FT) Programme and Three Year (Modular) MBA (PT) Programme for the session 2020-2021 run by the Centre for Management Studies (CMS), Dibrugarh University.

Eligibility for MBA (FT): Graduate (All streams except Music & Fine Arts) with 50% marks (45% for SC/ST) with any valid MAT/CAT/CMAT Score. Candidates in their Final Semester and waiting for their Examination/Results can apply provisionally.
