NOTIFICATION

In view of the Guidelines for home quarantine of the Government of Assam under unlock-3.0, for COVID-19 and as subsequent recommendation of the Committee constituted for Monitoring Home Quarantine cases in the Dibrugarh University, it is hereby notified for information of all Teachers, Officers and Employees of Dibrugarh University to kindly abide by the following rules :

1. All Teachers, Employees and Officers shall have to inform the Security Officer (duly authorized for the purpose) regarding the quarantine issues in their families, if any, at the earliest.
2. The Families / Persons already in quarantine shall have to follow strictly the guidelines and advisories issued by the Government of Assam as well as Central Government time to time.
3. Under the initiative of the Senior Medical Officer, Dibrugarh University, the Area Surveillance Officer, appointed by the District Administration will visit the quarantine families/person from time to time for monitoring and providing necessary medical assistance.
4. Entry into the University by the visitors / students is strictly prohibited till further notice (in exceptional cases visitors may enter the campus with the permission from the Security Officer). However, the domestic helps may be allowed with proper sanitization and Temperature check at the main gates of the University campus. Temperature checking, sanitization, submissions of travel details to the security personnel at the entry point are mandatory for all persons and to be strictly adhered.
5. Contractors of various constructions inside the University Campus are advised to provide a detailed list of the workers engaged in respective construction sites. They are further advised to confine the movement of workers inside the construction sites. Constructions related to Government Project or highly essential will only be allowed.
6. All teachers, employees and officers residing in the Dibrugarh University Campus are advised to travel under absolutely urgent / emergency situations only.
7. The Vendors, courier delivery personnel etc. are prohibited from entering into the University campus up till further notice.
8. Henceforth, the office of the University will run with full strength of employees.
9. Teachers, Officers, Employees of Dibrugarh University are requested to register their names for RTPCR COVID-19 Test in the University Campus on or before 01/09/2020. The Security Officer, DU has been entrusted upon the task of registration.
10. The Research Scholars whose date of submission of Ph. D. thesis is due within 6 months will only be allowed to stay in the Hostel. However, keeping in view the establishment of an Isolation Centre at the Dr. Lila Gogoi Memorial Goveshak Chatra Nivas, the Research Scholars (Boys) who fulfill the above criterion are requested to communicate with the Dean, Student Affairs.
11. All teachers, officers and employees are requested to download and install AAROGYA SETU app for information relating to COVID-19.
