
NOTIFICATION

Sub: Guidelines for conduct of B.A./B.Sc. 6th Semester Practical Examinations, 2020-regarding.

This is for information of all concerned that the following Guidelines must be followed for conduct of B.A. /B.Sc. 6th Semester Practical Examinations, 2020 by the concerned Colleges:


1. The concerned Colleges shall conduct the B.A. /B.Sc. 6th Semester Practical Examinations, 2020 in offline mode.
2. External Practical Examiners shall not be appointed by Dibrugarh University for conduct of B.A./B.Sc. 6th Semester Practical Examinations 2020.
3. The concerned Examination Centres should constitute a '**Monitoring Committee**' for conducting Practical Examinations consisting of at least one (01) Teacher of the Department (s) offering subjects having Practical components. The Principal/Officer In-Charge of the College/Examination Centre shall be the Chairperson of the 'Monitoring Committee'. It shall be the responsibility of the 'Monitoring Committee' for the overall conduct of Practical Examinations in the respective Examination Centre.
4. Dibrugarh University has discontinued the practice of providing Question Papers for B.A./B.Sc. Practical Examinations (*Please refer the notification issued by the Controller of Examinations vide No. DU/EX/CoE/Notification/20/914, dated 18.03.2020*). As such, the Principals/Officer in-Charge of the concerned Colleges/Examination Centres are requested to take necessary arrangement for setting the Practical Question Papers at their respective Examination Centres.
5. The Practical Examinations shall have to be completed **on or before 05.11.2020**.
