  - iii) Self-attested photocopy of the caste certificate (if selected under reserved category).
  - iv) Self-attested photocopy of the Permanent Residence Certificate.
  - v) Self-attested copy of the online application form submitted by the applicant.
  - vi) Self-attested copy of the DUPGET 2020 Score Card.
3. The candidates provisionally selected under the Statutory Reservations must produce PRC of Assam in original.
  4. The candidates who passed B.A./B.Sc. prior to 2020 shall have to produce Gap Certificate.
  5. In case of equal Score in DUPGET, the candidates securing higher percentage of marks at H.S. level are ranked higher.
  6. Admission from the waiting list against the vacant seats, if any, shall take place on **11<sup>th</sup> December, 2020 from 10:30 a.m. (In a previously uploaded version of this List, the date of admission against the waiting list was inadvertently mentioned as 11<sup>th</sup> November, 2020 instead of 11<sup>th</sup> December, 2020.)** Candidates must report at 10:00 a.m. positively.
