

2. The ARS shall undertake patrolling and make surprise visits to lace vulnerable incidents of ragging.
3. The ARS shall conduct on-the-spot enquiry into any incident of ragging referred to it by any student, employee, parents/guardians or any employee of a service provider or by any person as the case may be.
4. The ARS shall submit a report after a fair and transparent enquiry conducted along with recommendations to the Anti-ragging Committee for further action.
5. The ARS shall remain valid for a period of 03 years or until further order whichever is earlier w.e.f. the date of issue of this notification.

This dissolves the earlier constituted Anti-Ragging Squad constituted as per notification no. DU/SWS/ARC-ARS/98/2011/696 dated 28.07.2011.


