

**NOTIFICATION**

As recommended by the 151<sup>st</sup> Meeting of the Post Graduate Board, Dibrugarh University held on 03.03.2021 vide Resolution No. (07) and in compliance to the Office Memorandum issued by the Government of Assam vide No. AHE.639/2018/16, dated 10.06.2020, the Dibrugarh University is pleased to waive the admission and examination fees of the students pursuing 3<sup>rd</sup> and higher Semesters in various Academic Programmes having concurrence of the Government of Assam. In this regard, all concerned are hereby informed the following-

1. The students of the Teaching Departments/ Academic Programmes of Dibrugarh University having concurrence of the Government of Assam and having valid Domicile Certificate of Assam are eligible to avail the fee waiver scheme.
2. This Scheme does not cover the Hostel Admission and other Hostel fees.
3. This Scheme also does not cover the Teaching Departments/ Centres for Studies/ Academic Programmes of Dibrugarh University, which have not concurrence of the Government of Assam and run by University's own fund.


