



TWENTIETH (XX) CONVOCATION, 2022

NOTIFICATION

The XX Convocation of Dibrugarh University will be held tentatively in the Last Week of June, 2022. In the Convocation, degrees shall be conferred on the eligible candidates who had qualified for all degrees of the University (having cleared their Final Semester Examinations) during the period *from 01.12.2019 to 10.03.2022*. However, only the Certificates of *Post Graduate, M.Phil. and Ph.D. Degrees* shall be distributed during the Convocation. The Certificates of other Degrees shall be distributed on subsequent dates and venues, which shall be notified later on.

The Submission of *Online Application* of the *XX Convocation of Dibrugarh University* by the eligible intending candidates shall begin from *17.03.2022*. The last date for submission is *31.03.2022 (till 05:00 P.M.)*.

HOW TO APPLY

1. For submission of the *Online Application Form*, intending candidates are advised to follow the following instructions:
 - a) The candidate shall have to register in the portal www.dibru.online by entering Full Name, Username, Password and a Mobile Number to login. The candidate will get an "*Activation Code*" in the mobile which is to be entered for Activation.
 - b) After Activation, the candidates shall have to log in with his/ her user name and password and has to fill up the *Online Application* with correct and appropriate information.
 - c) The applicants shall have to pay the *Certificate Fee of Rs. 750/-* only through the *online payment gateway* by using Debit Card/Credit Card/ Internet Banking during the submission of form. *No other mode of payment is acceptable.*
 - d) The applicants can save and review the information entered before *Submission*, which can be edited on subsequent login. However, after Submission, editing of information shall not be possible.
 - e) On submission of the *Online Application Form* by an applicant, a Submission Receipt with a Unique Number shall be generated against each successful submission of Application. *However, a successful submission shall not imply that the application of a candidate is considered as correct and valid. This shall be ascertained after further verification by the University.*
 - f) After submission, the Application Form shall be generated in PDF Format, which may be saved or printed for future use. The applicants are advised to take a print of the *Online Application Form* for any future reference.
2. The Submission of Online Application Forms shall be automatically closed after the last date.


3. There shall be no alternative procedure for Application for participation in the XX Convocation and the University shall not receive the Application Fee except the procedure mentioned at 1 (c) above.
4. The subsequent notification related to XX Convocation shall be notified by the University from time to time.
