NOTIFICATION

In continuation to the earlier Notification vide Memo No.: DU/DR-A/8-1/21/290 dated 10.03.2021, the Hon'ble Vice-Chancellor, Dibrugarh University has approved the Grading System and Conversion Formula of the CGPA of the Bachelor of Social Work (BSW) and B.A. in Performing Arts Programmes in the CBCS with immediate effect-

GRADING SYSTEM

SCALE OF GRADING :

The following scale of grading system shall be applied to indicate the performance of students in a particular course in terms of letter grade and grade point:

Letter Grade with Meaning		Grade Point
O	Outstanding	10(Marks securing 90% and above)
A+	Excellent	9(Marks securing 80%-90%)
A	Very Good	8(Marks securing 70%-80%)
B+	Good	7(Marks securing 60%-70%)
B	Above Average	6(Marks securing 50%-60%)
P	Pass	5(Marks Securing 40%-50%)
F	Fail	0(Marks securing below 40%)
Abs	Absent/Incomplete	0

Exclusive Class Interval Technique shall be followed in calculation of Grade Point. For example, the class interval 70%-80% includes candidates securing percentage of marks starting from 70% upto any percentage less than 80%. If a candidate secures 'F' grade in a Course, or 'Abs' (Absent/Incomplete) he/she shall have to reappear in the Course in the next legitimate chance.

▪ **CALCULATION OF SGPA AND CGPA :**

$$SGPA \text{ (Semester Grade Point Average)} = (\sum C_i G_i) / (\sum C_i)$$

Where C_i = Number of credits for the i^{th} course
 G_i = Grade point obtained in the i^{th} course

- *SGPA will be weighted average of the numerical grade points obtained in all the Courses/Papers of the given Semester, where Weights refer to the Credits assigned to the concerned Courses/Papers.*

$$CGPA \text{ (Cumulative Grade Point Average)} = (\sum \sum C_{ni} G_{ni} / \sum \sum C_{ni})$$

Where C_{ni} = number of credits of the i^{th} course of the n^{th} semester
 G_{ni} = grade points of the i^{th} course of the n^{th} semester

- *CGPA over six Semesters shall be the weighted average of the six SGPA's.*



- The overall letter grade 'B+' and above shall be considered as First Class; and letter grade(s) 'P' to 'B' shall be considered as Second Class.


