#### **COURSES OF STUDY FOR Ph.D PROGRAMME**

The Ph.D. Course-work in Anthropology shall consist of four papers (two compulsory papers and two elective papers). The duration of the course will be six months. The candidate must choose one course from Paper-III (Elective) while Paper-I, II & IV are compulsory.

#### **Course structure and Examination pattern of the Ph.D Course-work**

#### Paper I : Research Methodology (compulsory paper)

100 marks

- **Unit I :** Scientific Research : Fieldwork and empirical studies in anthropology. Characteristics, Aims, Types and Methods. Research trend and Urgent Research in Anthropology of the region.
- **Unit II: Concepts, Constructs and Variables:** Conceptual and operational definitions, units of analysis. Types of variables. Hypothesis : meaning, nature, types, testing of hypothesis, formulation of research design, meaning of research design, functions and characteristics of good research design, selection of research topic. Book Review.
- Unit III: Methods and techniques of data collection: Pilot study. Sampling methods. Questionnaire and Schedule. Interview, observation, case study, Genealogy, Focused Group Interview, PRA, RRA and RAP.
- UnitIV: Data Processing and Analysis: Data processing, analysis and documentation of data, classification, tabulation of data. Analytical and comparative, Qualitative and quantitative data analysis, preparation of tables, figures and charts, Pedigree analysis and analysis of family data. Diagrammatic or graphic presentation of data: Frequency Polygon, Histogram, Bar diagram, Pie chart, population pyramid.
- Unit V: Statistical concepts and test of hypothesis: Measures of central tendency: mean, median, mode Measures of Dispersion and association: standard deviation, standard error, co-efficient of variation. Test of significance: Chi-square test, t-test. Bivariate analysis: Regression analysis Multivariate analysis: Multiple Regressions. Use of Computer softwares in anthropological research.

- **Unit I:** Thesis and Dissertation: Convention of writing, resources, selecting a topic, determining the thesis, literature review, designing the study, thesis proposal, ethical concerns, the chapter outline, Abbreviations commonly used in scholarly writing; ethnographic writing, postmodern critics and reflexivity.
- Unit II: Chapter Format, Quotations and Footnotes: Chapter divisions and sub-divisions, chapter headings, centered headings, side headings, paragraph headings. Formatting and style- margins, spacing, pagination, paragraph indentation, justification of text. Short quote and long quote; quoting, paraphrasing versus plagiarism; ownership of intellectual property; ellipsis, interpolations, special quotations. Footnotes- Use and placement of footnotes, format, conventions, problems in footnoting.
- Unit III: Editorial Style, Tables, Figures and Appendices: Common features of editorial style- capitalization, italics, numbers, shortened forms, fonts and point sizes, general matters of form, usage and editorial style; Table and figures- Placement, numbering, captions, format of tables and figures, preparation of figures, footnotes to tables and figures, pagination, margin, spacing and alignment of tables and figures; Appendices-use and format of appendix.
- Unit IV: Computer Tools: Computer tools for writing and publishing- text tools, word processors, spelling checkers, thesauri, grammar checkers, style analysers, mathematical symbols and equations, diacritical marks and other special characters; computer as information tool- electronic information resources, online database, electronic reference library (ERL), firstsearch, lexis/nexis, ovid, electronic journals; The internet and the world wide web- cautions with web material, finding way and evaluating information on the web-criteria for evaluating web sources, citing web sources.
- Unit V: Referencing System: Bibliography and references- Vancouver system, Harvard and APA systems, Author-date system; Essential informations- book references, journal article references, articles and chapters in edited works; Abbreviations, spacing, capitalization, alphabetical and chronological order of the source entrees; Referencing cited works; Special cases- translation of another authors work, anonymous publication, pseudonymous publications, association or institution as author, no author, conference papers and proceedings of conferences, unpublished papers, thesis, news paper articles; Referencing electronic information sources- films and videotapes, CD-ROMS, online book and reports, theses, journal articles, magazine articles, newspaper articles, papers, web and home pages, images and sound files.

Three Groups of Elective papers shall be offered to the students. Students belonging to a particular stream of specialization shall opt for that particular group of paper as given hereunder.

Broad and contemporary thrust areas of research in Anthropology are given in each Group of papers.
