As per the decision of Admission Committee, the 3rd merit list is prepared on the basis of attendance of candidates on the day of Admission i.e. 7th August, 2023 to take admission from the waiting list of 1st merit list dated 03/08/2023

As directed and approved by the DU Authority the Nine (09) seats of B.Ed. programme reserved for in-service teachers are converted into admission of fresh candidates and merit list is prepared.

The following candidates are provisionally selected for admission into the B.Ed Programme in the Department of Education, Dibrugarh University for the academic session 2023-2024 based on the Composite Score against the vacant seats. Candidates are directed to bring all necessary documents in original (along with a set of photocopy), which will be verified by the Department at the time of admission.

Admission Procedure:

- **The provisionally selected candidates shall have to be physically present in the Department of Education, Dibrugarh University, on 23.08.2023 as per the scheduled time for counseling/verification of their documents.**
- **In case of service holder, he / she shall have to produce the No Objection Certificate from the Competent Authority before the Admission Committee on the date of Admission.**
- **The candidates provisionally selected for Admission (under any category) shall have to bring the following documents on the date of admission:**

- i. B.Ed CET 2023 Score Card.*
- ii. Domicile Certificate/ Permanent Residence Certificate (PRC) of Assam.*
- iii. Undertaking on 'Provisional Admission' (Format of undertaking shall be available in the University website).*
- iv. Gap Certificate wherever applicable (in the form of Affidavit).*
- v. All documents in original for producing before the Admission Committee.*
- vi. The Admission Fee, Course Fee, etc (wherever applicable as per the Fee Structure given in the website).*
- vii. The Admission Fee, Course Fee, etc (wherever applicable) to be paid by the candidates at the time of admission through online mode.*
- viii. The Admission of the candidates shall be held in the Department on the scheduled date only.*
- ix. The Selection and Admission of the B.Ed Programme covered by this Notification shall be purely provisional and subject to fulfillment of requisite norms of Qualifying Examination(s) and other relevant criteria.*
