**2nd ADMISSION NOTICE for
M.A. in Women's Studies Programme for the academic session
2023-2024**

Online Applications are invited from the intending eligible candidates **who appeared in DUPGET 2023 in any subject** to apply for admission to the M.A. in Women's Studies Programme, for the academic session 2023-2024.

A. Eligibility for Admission:

- Valid DUPGET 2023 Score in any Subject
- Bachelor's Degree in any discipline from a recognized University with minimum 45% in Major/ Honours or aggregate or equivalent grade point.

B. Application Procedure:

1. Application for M. A. in Women's Studies Programme shall be through online mode only. No other means of application shall be accepted.
2. Online Registration for submission of Application Form will begin from **03.08.2023**. The last date for submission of application is **10.08.2023 (till 11.59 p.m.)**
3. For submission of the *Online Application Form*, intending candidates are advised to follow the following instructions:
 - a) For Online Application, please login to Admission Portal on <https://dibru.ac.in> or <https://erp.dibru.work/>
 - b) The Candidate needs to register on the portal by clicking the "Register" button and providing his/her name, mobile number and a password. The mobile number will be verified through an OTP. Please remember the password for login.
 - c) After successful registration, the candidate needs to login using his/her mobile number and the password.
 - d) After login, the candidate needs to click on the "Apply" button corresponding to the link of "M.A. in Women's Studies Programme" which will lead to an application form. *The candidate needs to fill up the application form step by step.*
 - e) After completion of the filling-up the Form Candidate needs to click the button "Submit and Review". A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit.

- f) After ensuring that all the information displayed on the Preview is correct, the candidate needs to click '**Pay now & Submit the application**' and pay the application fee of Rs 750/- only through online mode (Debit Card/Credit Card/Internet Banking).
- g) The application form will be considered finally submitted only when the application fee is successfully paid by the candidate and an online receipt is generated confirming the payment.
- h) There will be a button to download your Application Form and Admit Card for future reference.
- i) The submission of Online Application Forms shall be automatically closed after the last date.
4. There shall be no alternative procedure for Application for applying to the **M.A. in Women's Studies Programme** and the University shall not receive the Application except the procedure mentioned at (2) above.

C. Selection Procedure:

- a) For all candidates, a valid **DUPGET 2023 score in any subject is mandatory.**
- b) As the Selection of Eligible Candidates for admission to M.A. Women's Studies shall be done only on the basis the DUPGET, 2023 in any subject, and the selection and admission shall be purely provisional and subject to production of relevant documents of passing the qualifying examinations with requisite norms before the concerned Department/Centre for Studies/ College where he/she has taken admission. An Undertaking shall also be taken from the admitted students in this regard.
- c) Statutory Reservation and Relaxation Policy shall be followed as per the Government Rules by the University and its Affiliated/Autonomous Colleges while preparing the Merit List of the Candidates.
