Dissertation: DSE Course- POLD607

The CBCS Board in its meeting held on 02.02.2024 resolved to introduce the DSE Course "POLD607" (Dissertation Writing) in 4th Semester of the CBCS PG Programme as per the recommendation of the Board of Studies (BoS) in Political Science held on March, 07-08, 2022 and its subsequent approval by the competent Authorities of the University. The CBCS Board thus requests the authorities to approve the following modalities to conduct the examination of the course which are in line with the CBCS Regulations of the University.

A. In- Semester Examinations: 40 Marks

- In-Semester evaluations for 40 marks in the form of In-Semester Examinations/presentations will be conducted by the Course/ Dissertation supervisors in line with the CBCS Regulations.

B. End Semester Examinations: 60 Marks

- The Students shall have to submit a dissertation duly certified by the prospective Course Teachers. Since the Course is optional (DSE Course) therefore, a maximum of 02 (two) candidates shall be supervised by a Course Teacher of the Department.
- The dissertation shall have to be reviewed by the respective Course Supervisor and shall assess the Dissertation out of 60 marks (as per the CBCS Regulations).
- An External Examiner shall be invited to conduct Viva-Voce test as per the rules of the University before commencement of the End Semester Examinations.
- The External Examiner shall award marks in the viva-voce test (out of 60) and the marks given by the Course teacher for dissertation shall be aggregated to finalize the final marks.
- Plagiarism check of the Dissertation is compulsory before submission.
- The Students shall have to submit a digital copy of the dissertation to the Department.
- In case of field-visits, if so required, the students shall use the vacation period only of the University.

C. Publication:

- Supervisor to be co-author in case of any article publication.
- If the student desires to publish the Dissertation in a book form then permission must be obtained from the University authorities after the award of the degree.
