

**The Terms of References of the ICC shall be as follows :**

- The IC shall fully adhere to the UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Education Institutions) Regulations, 2015.
- Any complaint of sexual harassment, if received by the undersigned, shall be forwarded to the IC and it shall immediately act upon as per the above regulations.
- The IC shall keep all the original records pertaining to the case(s) filed in its safe custody with its record in a register and prepare annual status report with details of the number of cases filed and their disposal, and shall submit the same to the undersigned for forwarding it to the UGC.
- The term of IC shall be 3 (three) years. However, the term for the student representatives is for a period of 1 (one) year. They shall cease to be a Member of the IC in case they lose their status as a student of the University.
- The student representatives shall be called to attend the meeting of the IC only when the matter involves student(s).
