**M.Tech. in Petroleum Technology (Petroleum Exploration and Production) Programme
Academic Session 2024-2025**

Online applications are invited from eligible intending candidates for admission into the two year M. Tech. in Petroleum Technology (Petroleum Exploration and Production) programme of Dibrugarh University for the academic session 2024-2025.

PROGRAMME HIGHLIGHTS

- The Department of Petroleum Technology was established in 1969 at Dibrugarh University with an aim to produce technically qualified human resources for oil & gas industries. The M. Tech. in Petroleum Technology (Petroleum Exploration and Production) Programme has been approved by UGC & AICTE.
- There is a strong Industry - Academia linkage between the department of Petroleum Technology and oil exploration & production companies. In every semester, field training is conducted in nearby oil industries. Dissertation / Project works are carried out in oil industries on relevant topics under the joint supervision & guidance of internal faculty and industry experts. Guest lecture program are arranged regularly by inviting subject experts from OIL, ONGCL, BCPL, NRL and other research and academic institutes of the country.
- ONGC offers scholarship of Rs. 60,000/- to the topper up to 2nd Semester of the M.Tech. programme in Petroleum Technology (Petroleum Exploration & Production).
- Students who meet the prescribed eligibility criteria with valid GATE score card can take the advantage of AICTE scholarship of an amount Rs. 12,400/- per month for the entire duration of the program.

Eligibility:

- Candidates having B.E. / B.Tech. in Mechanical / Chemical / Petroleum Engineering and M.Sc./ M. Tech. in Applied Geology / Geology / Geophysics of any recognised university with a minimum of 55% marks in aggregate are eligible to apply. M.Sc. in Geology / Applied Geology/ Geophysics candidates should have Mathematics in their B.Sc. level. *Candidates appearing in their final semester qualifying examinations and whose results are awaited can also apply. However, they have to produce final semester mark sheet/grade sheet and pass certificate at the time of counselling & admission.*

Method of Selection for admission:

1. The selection of eligible candidates for admission into the M. Tech. in Petroleum Technology (Petroleum Exploration & Production) Programme shall be done on the basis of the percentage of marks obtained in the qualifying examinations. The formula for conversion of CGPA to percentage must be shown in the candidate's grad sheet. **For the final semester students, whose results are awaited, the percentage of marks obtained upto the 3rd/7th semester examinations will be considered for selection. However, on the day of counselling & admission, they have to produce the final semester grade sheet/mark sheet and pass certificate of the qualifying examination. The admission**

shall be purely provisional subject to production of relevant documents of passing the qualifying examinations with requisite norms at the time of counselling. An undertaking shall be taken from the admitted candidates in this regard. The GATE qualified candidates having valid score card will get preference in selection and admission into the program. The GATE score card has to be uploaded along with the application form.

2. Candidate applying under the statutory reservation seats must have to upload their relevant documents (certificate etc.) issued by the competent authority. In case of non production of such valid documents, applications will be considered under general category.
3. EWS students will be accommodated as per Dibrugarh University Guidelines for admission in PG courses 2024-2025.
4. Candidates applying under the Dibrugarh University employee quota must have to submit a print copy of the submitted application form, in advance, along with self attested relevant documents and a certificate from the competent authority of Dibrugarh University, at the office of the department of Petroleum Technology, during office hours, on or before **05/07/2024**.
5. The selected candidates must have to produce the original testimonials and certificates at the time of interview / counselling. They have to submit a print copy of the submitted application form along with self attested relevant documents.
6. The list of the selected candidates and date of counselling will be notified in the department Notice Board and on the university website (www.dibru.ac.in).

How to Apply

1. Application for admission into the **“Two year M. Tech. in Petroleum Technology (Petroleum Exploration & Production) Programme”** shall be through online mode only. No other means of application shall be accepted.
2. Online registration for submission of Application form will begin from **05/06/2024**. The last date of submission of application is **04/07/2024 (till 11.55pm)**.
3. For submission of the online application form, intending candidates are advised to follow the following instructions:

- (i) For Online Applications, please login to Admission Portal on <https://dibru.ac.in> or <https://erp.dibru.work/>
- (ii) The candidates need to register on the portal by clicking the “Register” button and providing his/her name, mobile number and a password. The mobile number will be verified through an OTP. Please remember the password for login.
- (iii) After successful registration, the candidates need to login using his/her mobile number and the password.
- (iv) After login the candidates needs to click on the “Apply” button corresponding to the link of “**M. Tech. in Petroleum Technology (Petroleum Exploration & Production) Programme**” which will lead to an application form. The candidates need to fill up the application form step by step.
- (v) After filling up the form, candidates need to click the button “Submit and Review”. A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit.
- (vi) After ensuring that all the information displayed on the preview is correct, the candidates needs to click “Pay now & Submit the Application” and they pay the application fees for Rs. 950/- (rupees nine hundred fifty only) through online mode (Debit card/Credit Card/Internet Banking).
- (vii) The application form will be considered finally submitted only when the application fees is successfully paid by the candidates and on online receipt is generated confirming the payment.
- (viii) There will be a button to download the Application form for future reference.
- (ix) The candidates shall have to take a print out of the Application form and bring the same for verification on the day of the counselling and admission.
- (x) The submission of Online Application forms shall be automatically closed after the last date.
- (xi) Candidates seeking admission under the Non-Statutory Reservation Quota in the category of **Sons and Daughters of the DU Employees /Retired Employees** shall have to submit a print copy of the submitted Online Application form of the “2 year M. Tech. in Petroleum Technology (Petroleum Exploration & Production)

programme 2024” along with self attested copies of all relevant testimonials and a Filled in Prescribed Form on or before 04/07/2024 (during office hours) at the Department of Petroleum Technology, Dibrugarh University [Please refer Clause No. 2 (IV) (b) of ‘Reservation and Relaxation Policy for admission into Post Graduate, Under Graduate, Advanced Post Graduate Diploma, Post Graduate Diploma, Dipolma and Certificate Programme (Revised upto February 2022) available in the Dibrugarh University Website]. A Certificate from competent authority of Dibrugarh University must be submitted.
