PART A - TERMS AND CONDITIONS

I. GENERAL INFORMATION

The tender bids duly complete in all respects, along with the necessary documents should be submitted to the Registrar, Dibrugarh University, Assam. The Technical Bids so received, shall be opened on 18/07/2024 at 02:30 *P.M.* in the Office of the Registrar, Dibrugarh University preferably in the presence of the representatives of the bidders. The Financial Bids of the Tenderers shall be opened on the same date or at a later date to be intimated to the Tenderers whose Technical Bids are found to be valid. Right to reject any or all Tenders, without assigning any reason thereof is reserved by Dibrugarh University.

1. Qualifying Criteria:

- i. The bidder should be a service provider of nationally / internationally reputed brand or its authorized dealer / distributor. Either the bidder or the service provider shall have work experience in dealing with the similar kind of supply and installation at central govt./ state govt. / institute of national importance / educational & research institutes for last three years. A copy of the completion certificate received from any of the institutes during the last two years should be submitted.
- ii. All the bid documents be supported by technical leaflet/ literature and the specifications mentioned in the quotation must be reflected / supported by such technical leaflet / literature.
- iii. Dealers or agents quoting on behalf of manufacturer must submit valid authorization certificate.
- 2. Service providers shall submit the following mandatory documents along with their bid document:
 - i) Valid **GST** Registration Certificate along with latest **GST return** copy.
 - ii) The bidder must submit a **detailed compliance statement** clearly mentioning compliance with the specifications mentioned in the NIT document and deviation if any.
 - iii) **Technical literature** regarding the offered services.
 - iv) The rates should be mentioned in the **FINANCIAL BID** attached with the bid document as in **ANNEXURE-II**. Each page of the bid shall be signed in full and stamped with the seal by the service provider. The service provider must clearly state in what capacity he/she is signing the Tender.
 - v) Average annual turnover of **minimum Rs 10 Lakhs** for the last 03(three) financial years 2021-22, 2022-23 and 2023-24.
 - vi) Valid ISO Certificate for OEM to be submitted
 - vii) Documents regarding **registered service provider office to be available within 50km** radius of Dibrugarh University to be submitted in their letterhead with seal and signature.
 - viii) Valid copy of Trade License or Certificate of Incorporation or Partnership Deed.
 - ix)**PAN** Card
 - x)The Bidder has to submit valid **ESIC/EPF / Labour License/ Trade License** etc.
 - xi)The cost of bid/tender of **Rs. 1000.00** (Non refundable) + 18% GST, only in the form of Demand Draft/Bankers Cheque in favour of the Registrar, Dibrugarh University, Assam payable at Dibrugarh University. xii)The Firm(s) who are registered with MSME, National Small Industries Corporation (NSIC) /OR Small Scale Industries (SSI) are **exempted** to submit the Tender Cost/EMD. However, a copy of registration **must be provided** along with Technical Bid.
 - 3. The bid will be evaluated on QCBS methodology in the ratio 70:30 i.e. 70% weightage will be given to the technical evaluation and 30% weightage will be given to the financial bid. The evaluation will consist of two phases Stage-A and Stage-B (as in **Annexure-III**).
 - 4. Service provider should read carefully all the instructions and terms and conditions, etc before registering rates in prescribed schedule of the tender. Taxes and duties etc. should be shown separately.

- 5. The quantity as mentioned in Annexure-I may be increased or decreased at the time of executing the agreement.
- 6. Tenderers are advised to study all technical and commercial aspects, instructions, forms, terms and specifications carefully in the tender document. Failure to furnish all information required in the Tender Document or submission of a bid not substantially responsive to the Tender document will be at the tenderer's risk and may result in the rejection of the bid.
- 7. The Bidder should not have been blacklisted in anywhere in India or abroad. A self –declaration letter by the Bidder on the company's letter head should be submitted along with technical bid.

II. SCOPE OF WORK

- i) The scope of work includes to check the performance of Water Purifier / RO System with cooler machines, Cooler and submit the report/job sheets after every visit. The scope of work also include unit check up and general cleaning, chemical cleaning of cartridge, if required, replacement of consumable items, as per the complaint during the AMC Period.
- ii) In case of any complaint / breakdown / fault in any equipment, the firm/agency has to attend the fault within 24 hours of reporting on Phone /Email etc. failing which will invite a penalty as mentioned in Clause no. 9.
- iii) The AMC is for preventive as well as for break down maintenance and includes repair and replacement of the following parts without cost during the AMC Period:
 - a) Pre-filter candle
 - b) Gas re-filling
 - c) Relay
 - d) Carbon
 - e) Membrane
 - f) Free replacement of consumables such as cartridges, candles, post carbons, membranes, auto cut flute are mandatory over in a year during the contract period or as and when required to get the desired water quality.
 - g) Repair of the electrical parts provided for the RO Plants including replacement of parts and rewinding as and when required.
 - h) The service provider shall employ full-time technically qualified staff(s) with adequate experience during the execution of the work and provide the names and contact numbers alongwith the bid document.
 - i) Offer must be on letterhead of agency and strictly as per Financial Bid format attached herewith as Annexure II.
 - i) The requirements of service for numbers of units may be varied at the time of placing the formal order.
 - k) The University shall not be responsible for any postal delay /loss in transit etc.
- **III. TENURE OF CONTRACT:-** The tenure of the contract shall ordinarily be one year. However, the competent authority Dibrugarh University, may at the discretion, allow extension of the tenure of contract, up to two spells of one year each subject to satisfactory services of the firm on the same terms and conditions.

The competent authority reserves the right to terminate the contract at any time before completion of the tenure in case the services of the firm are found unsatisfactory, and without assigning any reason what so ever.

- **IV. EXECUTION OF AGREEMENT:** The selected Bidder shall have to execute an agreement on AMC with immediate effect.
- **V. PROHIBITION OF SUB CONTRACT:** The firm / agency shall not appoint any sub-contract for this work under any circumstances.

VI. DEDUCTION OF INCOME TAX AT SOURCE: Since it is a "Works Job Order", Income Tax shall be deducted at source from all the accepted payment to be made, in accordance with the provision of Income Tax Act, 1961 as amended from time to time.

VII. RESOLUTION OF DISPUTE: All disputes are subject to "Dibrugarh Jurisdiction" only.

VIII.PENALTY CLAUSES: Deficiency in quality: In case of failure on the part of agency/firm to rectify the defect within a period of 24 hrs, the Dibrugarh University shall have the discretion to get it rectified from other sources at contractor's risk and cost.

Rs.500/- will be penalized, if the mechanic/technician does not visit the University for not attending the call/inspection/repairs.

The Dibrugarh University reserves the right to accept or reject any or all the bid documents without assigning any reason what so ever.

IX. PAYMENT: The 30% payment shall be made after execution of Agreement of AMC as advance payment and remaining 70% after successful completion of the job and submission of relevant service satisfaction certificate. A Bank Guarantee of 10% on contract value is to be submitted by the service provider at the time of agreement execution or else the amount will be deducted from the advance payment (in case Bank Guarantee is not submitted).

Note:

- (a) Bidders are advised to read carefully the Terms and Conditions of supply before recording the rates in this Schedule.
- (b) No erasure or overwriting shall be allowed, unless they are authenticated under the full signature and the seal of the tenderer.
- (c) The University reserves the right to:
