SPOT ADMISSION POLICY FOR THE FIVE-YEAR INTEGRATED POST GRADUATE PROGRAMME (FYIPGP) BASED ON CUET FOR THE 2024-2025 SESSION

Annexure A

For spot admission to the Five-Year Integrated Post Graduate Programme (FYIPGP) of Dibrugarh University based on CUET, the following procedure shall be followed:

- i. Dibrugarh University shall notify the date and reporting time for spot admission as per the guidelines received from the Higher Education Department, Assam.
- ii. The intending candidates shall have to apply for spot admission through the Samarth portal if they have not applied and report to the concerned Department of the University strictly on or before the reporting time with all the original documents.
- iii. After expiry of the reporting time, no new candidate shall be allowed for that day.
- iv. Candidates who reach the spot(concerned Department of the University) on or before the reporting time shall be eligible for consideration for selection against the vacant seats under different categories and the selection will be done on the basis of the CUET-UG Score 2024 for each vacant category subject to the fulfilment of basic eligibility criteria and submission of all the requisite documents.
- v. In case of two or more candidates securing equal marks in CUET-UG 2024, thenmerit shall be determined based on aggregate percentage in class 10+2 examination.
- vi. Candidates are advised to refer the Guidelines for Spot Admission 2024 issued by the Higher Education Department, Govt. of Assam (available at https://assamadmission.samarth.ac.in/)
- vii. For any matter not covered by the above clauses, the decision of the Competent Authority shall be final and binding.
